Ted called the meeting to order at 6:02 PM with 8 members present and 1 arriving.

Ted asked Fire Chief Jeff Blanchard to share with the committee and update on the property associated with Article 20 on the Annual Town Meeting Warrant. Jeff began his presenation with how we are where we are. Jeff talked about the land where that they have been interested in on Webster St. and Jeff read the final paragraph from the most recent communication from the Attorney who has been working with the town on this case. "The attorney's office is proceeding expeditiously to finalize the last filings with the Land Court which will result in a final review by the Land Court examiner in order to obtain an entry of Default Judgment. It is anticipated that the process to default judgment may be completed within 30-90 days."

Jeff then shared a computer model where with a 6-year history of response times for calls with 1 fire station in the center of town. There were green, yellow and red dots. Green for good response times, yellow acceptable and red outside the acceptable standards. Jeff then showed the same 6-year history of response times for calls with 2 fire stations (one in the center of town and one on Webster St) with the green, yellow and red dots. The number of red dots was greatly reduced in the North Hanover area and the the yellow dots were also reduced. The purpose of this data is to show that North Hanover is a great location for Hanover to build a new fire station. Jeff shared that there was no need to expand the current staffing levels with current call volumes. There was a question relating to building just an ambulance sub-station and the chief shared that everyone is a paramedic and fire (dual professional) not one or the

other and it would be under-utilizing their skill-set. There were no more questions, so Ted thanked Jeff for this valuable information.
