

These are the minutes from the August 24, 2021 Zoom meeting of the Hanover Board of Health. Present were Mr. John Dougherty - Board Member, Ms. Diane Sawin – Board Member, Ms. Kathleen Dauphinais, Ms. Kimberly Dixon – Health Agent, Mr. William Barrett – Asst. Health Agent

Having a quorum, Mr. Dougherty motioned to open the meeting at 4:30 p.m., Ms. Sawin seconded, all in favor.

Mosquito/Tick Update – Plymouth County Mosquito will be taking spray requests from residents until October 10<sup>th</sup>. There have been 57 cases of West Nile Virus in Massachusetts, none of which were in Plymouth County. There are no EEE pools in Massachusetts at this time. There have been very few Lyme disease cases in Hanover this summer as well.

Covid-19 Update – Ms. Funder advised the Board that there have been 27 cases of Covid-19 in the past week. There were zero cases in June and 96 cases in July. A mask mandate for school children K-12 will be implemented by the State until October 1, 2021.

Flu Clinics – Ms. Funder is in the process of planning for seasonal flu clinics. Clinics will likely begin at the end of September and go through October.

Health Agent Update – Ms. Dixon reported an issue at Elmwood Farm Drive Senior Apartments, there was a unit without hot water and the issue was resolved that day.

Hazardous waste day will be held at the Hanover Transfer Station on October 2<sup>nd</sup>.
