

These are the minutes from the August 7, 2018 meeting of the Hanover Board of Health. Present were Mr. John Dougherty - Chair, Mrs. Gabrielle Mahoney – Board Member, Delshaune Flipp – Board Member

Mrs. Kimberly Dixon - Health Agent, William Barrett – Assistant Health Agent, Mr. Joseph Stack, Building Commissioner, Mr. Stephen Leaman, owner Nautical Mile Market.

Mr. Dougherty having a quorum called the meeting to order at 6:03p.m.

New Business:

406 Columbia Road: The board discussed an issue that was discovered at Nautical Mile Market, 406 Columbia Road, Mr. Leaman stated that he was informed that an employee of his septic pumping company, Premier Portable Toilets was dumping waste from the portable toilets into the onsite disposal system at Nautical Mile Market, 406 Columbia Road. Mr. Leaman stated that his employee was not aware that you cannot pump into the onsite system. Mr. Leaman stated that they typically use Howland Disposal to pump their waste and remove it to the proper facility and that they have licenses to pump in Scituate, Marshfield and Duxbury. Mr. Dougherty asked if there was a business license for the portable toilet company, Mr. Leaman replied that there was not. Mrs. Dixon asked where the toilets were stored, and they are stored on B Street, in the industrial park. Mr. Stack stated that they are not permitted to be stored there. Mr. Stack stated that the pumping records should be brought forward as well as a title 5 performed on the property at 406 Columbia road.

Mrs. Mahoney made a motion to request a title 5 be done within 14 days, and that the pumping records are brought forward, Ms. Flipp seconded, all in favor.

Center School Septic System: The center school addition project is moving along, the septic system has been installed, however during recent pressure tests the lines were only reaching 15 to 16 PSI instead of the desired 30 PSI. The contractor will be adjusting the pumps as necessary to reach the desired pressure in order to move forward and obtain their certificate of compliance from the board.


Rockland Cares: Rockland cares is an opiod use support group out of Rockland. They will be sending a representative to the August 21st BoH meeting to have a discussion with the Board.

Tobacco Grant Update: A tobacco coordinator will be hired shortly, funded by a federal grant which was awarded. There was a question whether the recent tobacco grant which was awarded would have any money allocated for vaping, and it is believed to only be for tobacco and age compliance checks.

Fireworks Site: The board would like to attend some sort of on-site meeting at the fireworks site, possibly with the conservation agent to gain an idea how things are going regarding the site clean-up.

All Permits: General Health Permits

Mrs. Mahoney moved to adjourn, Ms. Flipp second; so voted unanimously. Meeting adjourned at 7:05 p.m.
