APPLICATION SUBMITTAL REQUIREMENTS

Deadlines for Applicants to meet:

- **ANRAD, RDA, NOI-** *applications that require a Public Hearing:*
14 days (by noontime)- prior to desired meeting date
- **SPECIAL USE PERMIT-** *for Open Space Parcels* or a **MINOR ACTIVITIES PERMIT:**
5 days (by end of workday) prior to your Event or **Variable** for minor activities
- **REQUESTS for Extensions, Certificates of Compliance, Revised Plan Review, and**
 other documents to be submitted for an on-going public hearing:
7 days (by 4:00) prior to desired meeting date
- **DISCUSSIONS – informal- at a Conservation Meeting:**
5 days (by end of workday) prior to desired meeting date (*may vary for special circumstances*)
