

These are the minutes from the March 10, 2015 meeting of the Hanover Board of Health. Present were Mr. Richard Farwell– Chair, Mrs. Lynn White – Board Member, Mrs. Robin McLaughlin –Board Member, Mr. Anthony Marino – Health Agent, Mr. Arthur Ceurvels – Assistant Health Agent, Mrs. Kimberly Dixon – Assistant Health Agent.

Having a quorum, Mr. Farwell called the meeting to order at 6:06 p.m.

Meeting Minutes:

Mrs. McLaughlin moved to approve the February 17, 2015 minutes, Mrs. White second the motion; so voted unanimously.

New Business

6:15 – Ecig & Vape – 333 Columbia Road – Lesley Deeb -This was the follow-up meeting for Mrs. Deeb with the Board. The Board had previously attended Mrs. Deeb’s store in E. Bridgewater. The Board found the employees knowledgeable and friendly. The Board has two requirements for the store in Hanover to allow sampling. The first is that the sample tray must be cleaned more often and use a cleaner source for actually breathing in the sample. The second requirement is the sample Vape will have zero nicotine in the dose for sampling. Mrs. Deeb was willing to order sampling cartridges and wipe down the sample box more often. The board will be allowing Mrs. Deeb sampling in her store with zero nicotine in the samples.

6:30 – Potable Well - 67 Washington Street – Caleb Estabrooks & Elizabeth Johansen – The residents attended the meeting and had submitted a complete well permit application on 3/9/15 to the Board for review. The Board is waiting to hear from Conservation and DPW before making an approval. In the meantime, it is the hope of the Board that the applicants at 67 Washington Street and 54 Old Shipyard Lane will be able to work together amicably in find a suitable location for the well that complies with the well regulations and works with the proposed septic system install at 54 Old Shipyard Lane.
