Jennifer Petit introduced Scott Curtis, the newly hired, Assistant Town Accountant. He has been working on developing monthly financial reports.

All Advisory Committee members were invited to attend a meeting with the Board of Selectmen on Monday, October 1, 2012. At this time, the Town Manager will provide an overview on the FY2014 budget process and timelines.

Troy Clarkson provided a summary of articles that are expected to be included on the November 13, 2012 Special Town Meeting warrant.

It was discussed that any of the remaining School vans, not being used by Town departments, would be going out to bid.

The demolition of the Curtis School is expected to begin on September 24, 2012.
