Program Proposals

Septic Repair Program: Trustee Steven Louko gave an update on the Trust on the Septic Repair Program. Mr. Louko said that advertisements will be up on the Town website soon.

Emergency Short-Term Rental Assistance Program: Mr. Burke gave the Trust an update on the Emergency Short-Term Rental Assistance Program. There was discussion of pledging more funds towards the program in the near future. Mr. Burke let the Trust know the program received two more applications.

Legion Housing

Finance Director Chelsea Stevens informed the Trust of the amounts and payments from the 121A agreement.
