

These are the minutes from the October 16, 2012 meeting of the Hanover Board of Health. Present were Mrs. Lynn White – Chair, Mr. John Dougherty – Board Member, Mr. Richard Farwell – Board Member and Mr. Anthony Marino – Health Agent, Mrs. Kimberly Dixon - Administrative Assistant.

Having a quorum called the meeting to order at 6:01 p.m.

Mr. Farwell moved to approve the October 2, 2012 minutes as written, Mr. Dougherty seconded, so voted unanimously.

Mr. Marino's Update:

- Mr. Marino reported that in keeping with state guidelines concerning curfews for the use of public fields due to EEE and West Nile carrying mosquitoes, that several local towns had lifted their curfews. It was determined that Hanover had experienced a killing frost. Because of a killing frost, the BOH voted to rescind the curfew on the use of town owned land. The board urged the public to continue to use personal caution and to follow the advice given by the Plymouth County Mosquito Control to wear clothing with long sleeves and pants, and to use bug spray. Mr. Dougherty motioned to approve the removal of curfew. Mr. Farwell seconded, all in favor unanimously.
- We had a successful flu clinic at the senior center, 140 people received shots on October 12, 2012.
- Mr. Marino briefed the BOH on the recent housing issues on Bardin Street. The Board commended Mr. Marino for his handling of this situation.

Appointments

- 17 Village Lane – Rosemary Baker – Title V report reviewed by Board to approve 6 bedrooms design, Mr. Dougherty moved to approve the change of bedrooms from 4 to 6 bedrooms per plans dated 2/7/93, system is designed for 672 gallons per day. Mr. Farwell seconded, so voted unanimously.
