## **Rules and Regulations**

## **Conservation and Open Space parcels in the Town of Hanover**

- No motorized vehicles, (except those that qualify will all ADA requirements) are allowed on any Conservation/Open Space parcel other than within parking areas. This includes cars, trucks, RV's, ATV's, motorcycles, dirt bikes, scooters, or any other vehicle that has a motor or engine (again, unless it is used by and for qualified ADA persons and criteria).
- Plant materials, vegetation, cuttings, soils, etc., shall not be removed from the site for any reason.
- All trash and other materials brought to the site must be removed at the conclusion of the event.
- No dumping of any materials or infringement into protected wetland areas is allowed.
- No overnight camping or parking is allowed, unless authorized by the Conservation Commission.
- Mo open fires are permitted on this site, unless authorized by the Conservation Commission.
- Stay on trails and away from stream banks to avoid damage to sensitive areas.
- DO NOT DISTURB or <u>FEED the wildlife</u>. Quiet observation will result in a richer experience. These areas serve not only as living and traveling areas for animal and insect wildlife, but also where natural vegetation grows for their food and protection.

Land under the jurisdiction of the Conservation Commission and/or the Open Space Committee is open to the public for *passive recreation only.* 

## Hiking, jogging, nature study, horseback riding, biking and fishing are encouraged.
