Re: Summary of Expenditures from Tronox Incorporated Expendable Trust Former National Fireworks Site, RTN 4-0000090

This memorandum presents the summary of all expenditures from the Commonwealth of Massachusetts, Tronox Incorporated Expendable Trust (Trust). The Trust was funded with amounts totaling \$68,919,419.09 pursuant to a Consent Decree and Environmental Settlement Agreement entered in *In re Tronox Incorporated, et al.*, Case No. 09-10156 (ALG), United States Bankruptcy Court, Southern District of New York; and, with interest, grew to a total of \$72,358,790.12. MassDEP ensures that the funds are expended, in accordance with the Declaration of Trust under which it was established, to reimburse or pay for response action costs in connection with the Former National Fireworks Site in Hanover, RTN 4-0000090.
