

These are the minutes from the December 13, 2016 meeting of the Hanover Board of Health. Present were: Mr. Arthur Ceurvels - Project Manager, Mrs. Robin McLaughlin – Chair, Mr. John Dougherty - Board Member, Mr. Richard Farwell – Board Member, Mr. Will Barrett – Computer Support and Mrs. Joanne O'Connor - Administrative Assistant. Additional attendee, Mr. Stephen B. Nelson from Clearwater Recovery.

Having a quorum, Mrs. McLaughlin called the meeting to order at 6:00p.m.

Meeting Business:

Mr. Farwell moved to approve the meeting minutes from November 29, 2016 as written, Mr. Dougherty seconded; so voted unanimously. Mr. Dougherty moved to approve the minutes from October 4, 2016 as written, Mrs. McLaughlin seconded; so voted unanimously.

Mrs. McLaughlin made mention of invitation to Board of Health members to attend the ribbon cutting at the Open House for the new D.P.W. Operations building at 219 Winter St. on Friday, Dec. 16th from noon to 3pm. Also, another invitation to the Council on Aging Strategic Plan meeting on Jan. 11, 2017 at 5pm was discussed.

Plans:

32 Post Drive – Stephen B. Nelson from Clearwater Recovery came in to present his plans dated 12/2/16 to reuse the existing tank and remove then replace the existing D-box. He used the results of Test Pit #2 as suggested by Mr. Jim Donovan (engineer) and determined that the Frimpter Calculation met his initial design criteria of the leaching field. Mr. Ceurvels asked Mr. Nelson to indicate how the new D-box will be connected to the existing septic tank and initial the change on the drawings.

766 Main St. – Morse Engineering Inc. – Plans originally dated 11-3-16 and revised 12-5-16. Approved as submitted.

466 Broadway – Morse Engineering – Plans originally dated 10-27-2016 and revised 11-23-16. Approved as submitted.

128 Washington St. – Morse Engineering – Plans originally dated 11-9-16 and revised 12-5-16. Mr. Farwell made motion to accept plans with deed restriction after noting perc rate on Test Pits #1 and #2. Mrs. McLaughlin seconded. So voted unanimously.

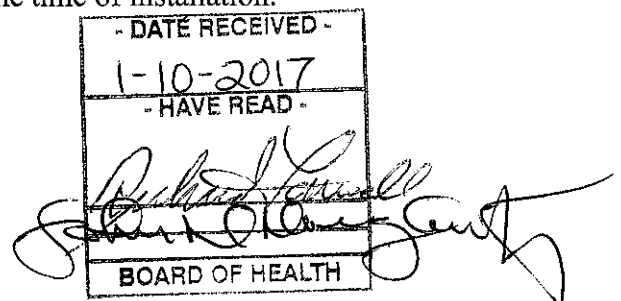
