### Public Hearing 637 Washington Street, Starland

Peter Allegrini of Signs by Design, presented the sign design and explained it is to direct the people to the right entrance. The applicant responded, apartments, Special Permit meet all

justifications of 5.87B.

Public Hearing, 1987 Washington Street: Cumberland Farms
