The Town Manager's Office has already started the process to obtain an appraisal. Currently, as a reminder, the Sylvester School building is being used for document storage as we push forward with our plans to digitize files and clean-up the basement of Town Hall. It's also being used from time to time as a training facility for area police and fire departments.

In the Town Manager's opinion reissuing an RFP for the reuse of the Sylvester School is a lower priority relative to a number of other more pressing matters such as (i) water quality (ii) Cedar School upgrades (iii) Tennis Courts project (iv) Hanover Crossing (v) etc. In other words, there is time to ensure that the reissuance of an RFP is done properly, and it's important that we keep our workload somewhat in check so that we do not spread our resources so thin that quality starts to erode.

It's anticipated that the Board of Selectmen will make a motion to reissue a Request for Proposal for the Edmond Q. Sylvester School, in accordance with the Board of Selectmen's Statement provided at Town Meeting on May 13, 2019, and said Request for Proposal will not be issued until the Board of Selectmen, by majority vote, authorize its issuance in final form
