**Hanover Planning Board
Public Hearing Guidelines**

The meeting will be conducted with decorum. This means the members of the Board and the public are Required to respect each other at all times. We may not always agree with one - another but we can work to resolve differences with patience and understanding.

As a member of the public you are encouraged to participate in the hearing. To ensure the meeting precedes in an orderly manner, please follow these rules:

- Ensure that you have signed into the meeting (sign-in sheet located at front of room on desk)
- Once the chair opens up the meeting for public comment, when you are recognized to speak, please state your name and address.
- Direct all questions to the board.
- Limit your question and or statement to 3 minutes. After everyone has been given a turn to speak, you may be given a second chance to speak
- Limit all statements to topic at hand
- Talk only about the jurisdiction under of the Planning Board.

The order of discussion is as follows:

- The applicant will make a presentation.
- The Board will respond to the applicant.
- The Chair may open the hearing for the public comment.
- The board will at that point:
 - a. Close the hearing: no new information will be accepted except under extra ordinary conditions.
 - b. Continue the hearing to a date certain where all will be permitted to participate. The date and time of this continuance will be announced ONLY at the first and subsequent meetings.
