## Minutes of the Regular COA Board Meeting, May 13, 2019

The Regular Meeting of the Hanover C.O.A. Advisory Board was held on Monday May 13, 2019, at the Hanover Senior Center. The meeting was called to order by Chairman Dick Farwell at 9:00 AM. One member was absent Ellie Kimball. Present were Dick Farwell, Les Molyneaux, Carol Mattes, Claire Flynn, Don Buckley & Roger Leslie. Additional attendees were Director Tammy Murray, Staff – Nancy Lester and Jen Dunn.

The minutes from the April 8, 2019 regular meeting were accepted.

Tammy Murray shared her Director's Report from April 6<sup>th</sup> through May 10<sup>th</sup> and Statistics FY 2019. The 2020 budget was approved at the annual town meeting and Tammy wants to be sure the case is made for the need for a part-time chef for daily light nutritious lunches or special dinners. 15-19 hours per week. Tammy shared that Carol and she met to view the Policy Handbook and that many of the policies need to be reviewed against town policies. The Handbook will be reviewed and will be placed on a future agenda for review.

Tammy shared that Hanover has been chosen for Blue Cross/Blue Shield's, Silver Sneaker exercise class through 12/31/19.

Tammy submitted the AARP grant for KNOX boxes. These are boxes that will store a key in case of emergency at residences, so no doors have to be broken down.

Tammy shared that the staff continues to attend trainings appropriate for their positions. On May 15<sup>th</sup> there is a training regarding setting boundaries when working with a senior community, board members are welcome.

The board with Tammy discussed the steam table and Tammy shared that the removal request has been submitted along with a request for a new door for Ben's office that has a window.

Les Molyneax, Ellie Kimball, Carol Mattes and Tammy will meet on 5/20 to review the Strategic Plan.

Tammy shared that we will have additional pages in "Happenings" beginning in July, so we will be able to provide more and in-depth information in the newsletter.

There will be a Summer Party with a Jazz Trio. Date to be announced soon!
