At 7:00 PM Chairman Barthelmes opened the meeting and asked if any member of the audience had any comment or discussion item for the Open Forum portion of the meeting; no response.

The Board received "An Act to Modernize Municipal Finance and Government" the TM noted the Act includes some procurement laws, some provisions have been identified as controversial. This is being presented for the Board to review and provide comment at a future meeting.

## **Town Manager Report**

- The Budget is due on February 1, 2016 and there will be a joint meeting of the Board of Selectmen and the Advisory Committee.
- The departmental budget submittal deadline has past and we do not anticipate any surprises.
- Updated capital requests have been submitted by Department Heads and have a five year plan.
- Pressures with health insurance budgets.
- Level of services will not be impacted.
- The Budget is balanced without the use of free cash.
- The timeline is similar to that of last year.
- GFOA document again this year.
- Provided a handout to the Board on the hunting concerns.

  - Enforcement activity
  - o Conservation Commission has posted more signage
- Joanne Simmons tenure has ended with Cardinal Cushing; the TM will meet with the interim CEO.
- Nathan Pina's internship is ending; he has been a wonderful addition; contributing to the audit website and the survey at the Council on Aging.

Chairman Barthelmes asked if any member of the audience had any comment or item for discussion for the Open Forum portion of the meeting; Kevin Zygadlo suggested the Selectmen be careful with non-profits, signage and donations for the total transparent view.

At 8:01p.m. Chairman Barthelmes requested a Roll Call Vote of the Board to go into Executive Session in accordance with MGL 30A, Section 21, <u>Subsection 2</u> to conduct strategy sessions in preparation for negotiations with nonunion personnel or to conduct collective bargaining sessions or contract negotiations with nonunion personnel and MGL 30A. The Board will not reconvene in Open Session. Roll Call Vote: Chairman B. Barthelmes, aye; Vice Chairman Setterland, aye; J. Salvucci, aye; Robert O'Rourke, aye and David Delaney, aye. Town Manager Troy B.G. Clarkson and Executive Assistant Ann Lee were also present. Any discussion relative to Police or Fire Selectman Salvucci will recuse himself.
