

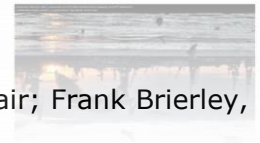

6:30 PM Chairman Paradis opened the meeting and made the following announcements:

I. ANNOUNCEMENTS & DATES TO REMEMBER:

II. DISCUSSION:

1. Open Space Committee- Update

Harold Thomas, Co-Chairman, Open Space Committee, Judy Grecco, North River Commission and William Soule were present to discuss a plan to enhance the trail system on the Shinglemill Brook Conservation parcel. He noted that some of the proposed trails were located on private property necessitating an easement from the property owner for use by the public. Ways to fund the project and continued maintenance were discussed. Commissioner Brierley recommended reaching out to Scout groups for the bridge and boardwalk projects. Ms. Grecco noted that volunteers from The Elms subdivision have volunteered to work with the Open Space Committee. A Notice of Intent application will be submitted in the upcoming Spring as this project includes wetland crossings. Mr. Thomas thanked the Commission for its continued cooperation.

IV. PUBLIC HEARINGS:

1. **BL 16-02, 353, 353r, 517 Circuit St.-** NOI- *for utility project in buffer and within BVW¹- See applicant's request to continue hearing to Feb. 17, 2016 at 7:00 PM.*

PRESENT: none

DISCUSSION: none

VOTE: Upon a motion and second made by Commissioners Brierley and McLoone, it was voted 4-0-0 to continue the public hearing to March 2, 2016 at 7:00 PM as per the applicant's request.

2. **BL 15-49, 23 Old Barn Rd.-** NOI- *for inground pool in buffer to BVW and within vernal pool habitat*
PRESENT: Joshua Bows, PE, Merrill Corp., Applicant's Representative; Wissam Bassil, Applicant/Property Owner
DISCUSSION: Mr. Bows presented a revised plan showing that all proposed work for the inground swimming pool has been relocated out of the 35 ft. *no-structure* setback to wetlands. He noted that a Zoning Board of Appeals hearing is pending for a waiver to the 20 ft. side property line setback.
Regarding restoration of the previously permitted buffer restoration², only native New England species of buffer zone plants shall be used. To eliminate negative impacts to the 25 ft. *no-disturbance* setback to the BVW from relocating the fence, the Order will include a condition for extending the buffer zone plants to the end of the fence. The fence may be located as per the revised plan dated 1/19/16 by using manual methods with no concrete footings to keep alteration to this area at a minimum. Once mitigation work is done, the 25 ft. buffer on this lot will remain a no-disturbance zone in perpetuity. The Commission accepted the 3:1 replication of buffer zone near wetland flags 4 and 19, as presented on the revised plan. In addition, 2 conservation posts will be installed at the 35 ft. (at property line and near mitigation area) with final location as per the Conservation Agent. Other conditions include standard inground pool conditions, and that the Order will be contingent on ZBA approval of the 1/19/16 Pool Plan.
VOTE: Upon a motion and second made by Commissioners Brierley and McLoone, it was voted 4-0-0 to close the public hearing.
Upon a motion and second made by Commissioners McLoone and Satterwhite, it was voted 4-0-0 to issue the Order of Conditions with conditions as stated above.
3. **BL 15-53, 132 Spring St.-** RDA- *for resource area delineation/determination of pond status*
