Approval of Minutes

Joan Port-Farwell made a motion to accept the minutes from *March 23, 2016*. This was seconded by Emmanuel Dockter. All were in favor and the motion passed.

Victor Diniak - Director of Hanover Public Works

Victor Diniak discussed with the Committee changes to water related articles on the Hanover Annual Warrant. **Article 31-Union Street Standpipe** will be withdrawn from the warrant. **Article 29-Water Treatment Plants** could have a possible cost increase from \$1,400,000 to \$1,519,000. This is due to changes in the required repairs. Mr. Diniak is still looking for further clarification of these change and is seeking an itemized list of the cost changes from the vendor. **Article 30-Water Mains** also has a possible increase from \$200,000 to \$500,000. Again, Mr. Diniak is working on getting a detailed list of the cost changes for the proposed work, and will keep the Committee posted on future developments.

William Scarpelli - Chairman, Community Preservation Committee

William Scarpelli discussed Community Preservation Committee warrant articles with the Committee. The CPC has 6 articles on the warrant this year and have been very conservative with the articles they put forth. Article 43-Affordable Housing Trust is 10% of the fund for the creation & preservation of affordable housing. Article 44-Open Space Plan appropriates funds for the preservation of open space in Hanover. \$20,000 from the town qualifies the Open Space Committee to apply for additional money through grants. Article 45-Foundation Wall Stetson House Barn appropriates \$35,000 for repairs. A figure of \$75,000 was originally proposed and rejected by CPC. The \$35,000 gives the Historical Commission the ability to match those funds through a grant from the Massachusetts Historical Commission. Chris Martin stated that he believes the repair can be done for less and inquired where the additional money would go if he is correct.

Mr. Scarpelli stated that he will look into the matter. Article 46-Trails appropriates funds to improve and maintain wooded recreational trails within Hanover. Article 47-Roll of Honor Restoration appropriates funds to restore World War II Honor Roll plaques from 1946. Article 48-Veterans Honor Garden appropriates funds to build a memorial for all veterans of Hanover. Chris Martin inquired if the Community Preservation Committee was agreeable to the idea of creating a CPC stabilization fund in order to set funds aside each year for large, future project. Mr. Scarpelli stated that the CPC has discussed the idea but has not voted on it. Mr. Scarpelli also reiterated that CPC is being very diligent and conservative regarding what applications they will support. Any money not spent remains in their fund, and the CPC is very aware of future project they could accumulate money for such as the reuse of the Sylvester School. Both Chris Martin and Edward Hickey stated that they are pleased with the CPC's fiscally responsible approach to applications.

Ray Miller - Chairman, Veteran's Memorial Committee

Ray Miller discussed with the Committee the status of the Veteran's Honor Garden project to be located next to the new bandstand at B. Everett Hall Field. Warrant **Article 48-Veterans Honor Garden** would appropriate \$50,000 to help with the cost of the project. Mr. Miller explained various portion of the project including layout and design as well as engraved bricks and benches that will be sold to raise funds for the project. Mr. Miller inquired regarding using the remaining portion of the \$25,000 that was appropriated at last year's town meeting. Chris Martin stated that unfortunately the funds can only be used for design given the language of the approved warrant article. Chris Martin suggested the Veteran's Memorial Committee set up a table at Hanover Day to raise funds for the project. The Committee thanked Mr. Miller for the update, and he departed at 7:47 pm.

Warrant for Annual Town Meeting Motion and Commentary Review:

Article 21 – Appropriate Funds – Fire Command Vehicle:

After a discussion regarding the public safety value of the proposed vehicle, Joan Port-Farwell made a motion to support the article. This was seconded by Sandra Hayes. All were in favor and the motion passed. After review, Joan Port-Farwell made a motion to accept the motion as written. This was seconded by Sandra Hayes. All were in favor and the motion passed. Angela Blanchard abstained from both votes. After further discussion regarding a proposed change in the amount of funds to be appropriated, Jerry O'Hearn made a motion to re-open the motion. This was seconded by Sandra Hayes. All were in favor and the motion passed. Joan Port-Farwell made a motion to amend the motion from \$60,000 to \$55,000. This was seconded by Emmanuel Dockter. All were in favor and the motion passed. The following commentary was proposed: This continues the Fire Department's systematic replacement and recycling of emergency response vehicles to ensure that adequate resources are available for fire and emergency management use. The Advisory Committee worked with the Fire Chief in evaluating the size and requirements of this vehicle and was able to achieve moderate cost savings. Edward Hickey made a motion to accept the commentary as written. This was seconded by Joan Port-Farwell. All were in favor and the motion passed.

<u>Article 19 – Purchase Police Department Vehicles:</u>

Edward Hickey made a motion to accept the motion as written. This was seconded by Jerry O'Hearn. All were in favor and the motion passed. The following commentary was proposed: This continues the Police Department's systematic replacement and recycling of high mileage vehicles to ensure that the vehicles are on-line and available for police use. The Advisory Committee notes the police vehicles to be replaced are used around the clock and have met their expected useful life. Sandra Hayes made a motion to accept the commentary as written. This was seconded by Joan Port-Farwell. All were in favor and the motion passed.

Article 32 – Appropriate Funds – One Ton Dump Truck:

A discussion was had regarding the merit of this article. It was agreed the Committee would revisit this article after Emmanuel Dockter spoke further with Robert Murray.

Article 33 – Appropriate Funds – John Curtis Library - Restoration:

Sandra Hayes made a motion that the Town not accept this article and take no further action. This was seconded by Jerry O'Hearn. All were in favor and the motion passed. The following commentary was proposed: The Advisory Committee toured the library and determined that the carpets and overall condition of the Children's Library is excellent. This expenditure is not necessary at this time. Edward Hickey made a motion to accept the commentary as written. This was seconded by Joan Port-Farwell. All were in favor and the motion passed.

Article 34 - Appropriate Funds - Replace Carpets - Town Hall:

Edward Hickey made a motion that the Town not accept this article and take no further action. This was seconded by Wayne Moores. All were in favor and the motion passed. The following commentary was proposed: The Advisory Committee toured the town hall and determined that the overall condition of the carpets does not warrant replacement. This expenditure is not necessary at this time. Joan Port-Farwell made a motion to accept the commentary as written. This was seconded by Wayne Moores. All were in favor and the motion passed.

Article 35 – Appropriate Funds – Cedar School Flooring:

A discussion was had regarding this article and some commentary was suggested. The article will be revisited at a later date.

<u>Article 36 – Appropriate Funds – Tractor/Snow Blower:</u>

Jerry O'Hearn made a motion that the Town not accept this article and take no further action. This was seconded by Wayne Moores. All were in favor and the motion passed. The following commentary was proposed: The Advisory Committee believes that the current snow removal equipment is adequate to meet the needs of the High School Campus sidewalks. This expenditure is not necessary. Jerry O'Hearn made a motion to accept the commentary as written. This was seconded by Angela Blanchard. All were in favor and the motion passed.

<u>Article 1 – Accept Reports in Annual Town Report:</u>

Emmanuel Dockter made a motion to accept the motion as written. This was seconded by Jerry O'Hearn. All were in favor and the motion passed. The following commentary was proposed: *This is a standard procedural article for the Town to accept the annual report.* Angela Blanchard made a motion to accept the commentary as written. This was seconded by Wayne Moores. All were in favor and the motion passed.

Article 2 – Hear/Accept Reports of Committees & State Officials:

Emmanuel Dockter made a motion to accept the motion as written. This was seconded by Sandra Hayes. All were in favor and the motion passed. Jerry O'Hearn made a motion to accept the commentary as written. This was seconded by Sandra Hayes. All were in favor and the motion passed.

<u>Article 3 – Authorize Treasurer to Accept Trust Funds:</u>

Sandra Hayes made a motion to accept the motion as written. This was seconded by Emmanuel Dockter. All were in favor and the motion passed. The following commentary was proposed: *This article allows the Treasurer/Collector to accept trust funds that are donated to the Town during the fiscal year.* Emmanuel Dockter made a motion to accept the commentary as written. This was seconded by Angela Blanchard. All were in favor and the motion passed.

<u>Article 4 – Authorize Treasurer to Dispose of Tax Title Land:</u>

Sandra Hayes made a motion to accept the motion as written. This was seconded by Joan Port-Farwell. All were in favor and the motion passed. The following commentary was proposed: *This article allows the Treasurer/Collector to sell property that the Town has acquired through the tax title foreclosure process.*

Emmanuel Dockter made a motion to accept the commentary as written. This was seconded by Wayne Moores. All were in favor and the motion passed.

Article 5 – Enter Into Compensating Balance Agreements:

Emmanuel Dockter made a motion to accept the motion as written. This was seconded by Sandra Hayes. All were in favor and the motion passed. The following commentary was proposed: *This article gives the Town Treasurer/Collector the option to enter into compensating balance agreements as a method of cash management.* Emmanuel Dockter made a motion to accept the commentary as written. This was seconded by Jerry O'Hearn. All were in favor and the motion passed.

Article 6 - Assume Liability to Allow State DEP Work:

Emmanuel Dockter made a motion to accept the motion as written. This was seconded by Sandra Hayes. All were in favor and the motion passed. The following commentary was proposed: *Each year, the Town is required by the State to assume responsibility for liability and damages which may be incurred by the State while improving, developing, maintaining and protecting tidal and non-tidal rivers. This article will acknowledge and accept that responsibility.* Emmanuel Dockter made a motion to accept the commentary as written. This was seconded by Joan Port-Farwell. All were in favor and the motion passed.

<u>Article 7 – Set Pay for Elective Officers:</u>

After discussion, it was agreed to revisit this article after arranging a meeting with Cathy Harder-Bernier the Hanover Town Clerk.

<u>Article 10 – Appropriate CPC Revenues For FY2017:</u>

Emmanuel Dockter made a motion to accept the motion as written. This was seconded by Sandra Hayes. All were in favor and the motion passed. The following commentary was proposed: *The Community Preservation Act requires that a minimum of 10% of the annual revenues of the fund must be set aside in each of the three categories of open space and recreational use, historic resources and community housing and an administrative budget of 5%. The budgeted reserve is set up as an additional annual reserve and may be used to fund any eligible Community Preservation projects. This article also provides funds to support the debt payments. Emmanuel Dockter made a motion to accept the commentary as written. This was seconded by Wayne Moores. All were in favor and the motion passed.*

General Discussion

Edward Hickey reiterated the benefit of the CPC being more diligent in their application review. Chris Martin would like to consider adding language in warrant articles to give a time frame for completion of the project. Janine Smith will inquire with town counsel regarding possible language. Chris Martin would like to invite the Town Clerk to the next meeting if possible.

Next Meeting

The next scheduled meeting is on Wednesday, April 6th at 7pm. The Hanover Town Clerk Cathy Harder-Bernier will be invited to the next meeting to discuss **Article 39-Voting Machines** and **Article 7–Set Pay for Elective Officers**.

Adjournment

Angela Blanchard made a motion to adjourn the meeting. The motion was seconded by Joan Port-Farwell. All were in favor and the meeting adjourned at 8:59 pm.
