The following minutes are from the meeting of the Hanover Community Preservation Committee held Wednesday October 9, 2013.

The following Committee members were present: Diane Campbell, Wally Kemp, Mike Holland, William Scarpelli, Richard Deluca, and Jonathon Goldthwait.

The Chairman Diane Campbell opened the meeting at 7:00 p.m.

The Committee reviewed the minutes from September 19, 2013 CPC meeting. Mike Holland made a motion to accept the minutes as written. Jonathon Goldthwait moved the motion. All others voted in favor.

Diane Campbell read the public hearing notice published in the Hanover Mariner on Wednesday September 25, and October 2 in to the record.

The Committee reviewed CPC Articles for the Fall 2013 Special Town Meeting.

Diane Campbell read Article 2 into the public record. Article 2, (CPC 14-01) Forge Pond Park – Supplemental Funding was submitted by Mike Tivnan, Chairman of the Hanover Park & Recreation Committee. This article is for \$240,000 dollars to fund the construction of dugouts for baseball and softball fields at the cost of \$140,000 and an additional \$75,000 was added for a landscaping design of the park and landscaping features. Hal Thomas of the Hanover Open Space Committee was concerned that an extraordinary amount of Open Space CPC funds were being used on the King Street field project. The Committee recommended the additional \$75,000 to create a professional entrance and foster community pride. William Scarpelli made a motion to recommend and amend the article to state that the \$75,000 for landscaping purposes only subject to the creation of a formal plan submitted to the CPC Committee prior to the utilization of landscaping funds. Jonathon Goldthwait seconded the motion. Diane Campbell, Mike Holland, William Scarpelli, Richard Deluca, and Jonathon Goldthwait voted in favor of the article. Wally Kemp voted nay.

Diane Campbell read Article 4 into the public record. Article 4, (CPC 14-03) Hanover High School Recreational Facility Engineering & Design Study was submitted by Robert F. Murray, Facilities Engineering Manager Town of Hanover. The application asks for \$65,000.00 dollars to study the recreational field design at the Hanover High School. The committee discussed the article and if CPC funds should be spent on such a project. Jonathan Goldthwait made a motion to not to support Article 4. Mike Holland seconded the motion. All others voted in favor.

Diane Campbell read Article 5 into the public record. Article 4, (CPC 14-02) looks to develop a Pocket Park at Gallant Field on the Curtis School Lot – Design. Application submitted by Mike Tivnan, Chairman of Hanover Park and Recreation Committee & Lauran Devine, Recreation Administrator. This article requests \$20,000.00 for the design of a pocket park which will incorporate recreational & historical components to its design. William Scarpelli made a motion to recommend this article to the Special Town Meeting. Wally Kemp seconded the motion. All others voted in favor.
