**New Business:**

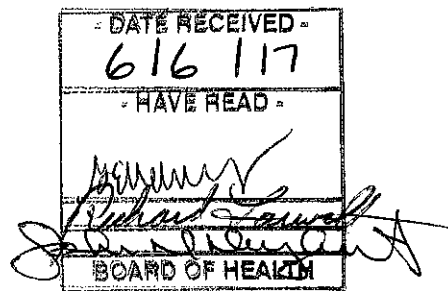
