Coronavirus Preparedness – Town staff began preparing a local emergency response plan for in late January and will continue to ramp up our efforts. Please follow us on <u>social media and on our website</u> for the latest news and updates.

Fiscal Year 2021 Budget – The Town Manager presented his FY2021 budget to the Board of Selectmen and Advisory Committee on February 4th. All budget materials are available on our <u>Finance Department Budget Information page</u>.

Senior Tax Work-Off Policy – Staff has been working with the Board of Selectmen on adopting a policy to give more structure to the Senior Tax Work-Off Program. The program and the policy are aimed at promoting the town's ability to utilize the skills and knowledge of our seniors in support of enhanced municipal government operations and to provide seniors with acute and/or persistent financial needs the opportunity to have their property taxes abated to further achieve the communities desire of keeping housing affordable for the senior population. Review a draft of the <u>Review a draft of the policy</u>.

Traffic Calming, Traffic Safety, and Pedestrian Infrastructure Augmentation Policy – In response to the Planning Board's review of the Hanover Crossing project (2019) and the emphasis placed on the Walnut Hill neighborhood, the Board of Selectmen adopts this policy to provide general guidance to staff, residents, business owners, the Planning Board, Advisory Committee, Town Meeting voters, and other stakeholders clarifying (i) the types of improvements the town will support (ii) types of improvements the town will not support (iii) the decision-making mechanism, process, and timeline (iv) general guidance on funding. <u>Review a draft of the policy</u>.

Procurement Policy – The Finance Director (and Chief Procurement Officer) is working with the Board of Selectmen to update the town's procurement policy.

Ambulance Billing, Collections, and Rate Setting Policy – On February 4th the Board of Selectmen amended its current policy to ensure that ambulance rates charged by the Town of Hanover are reviewed annually.

Walnut Hill Traffic Safety Pilot Project – The Board of Selectmen are currently reviewing a recommendation from the Traffic Safety Committee to try a two (2) week pilot project which would close the Walnut Hill neighborhood at the Rte. 53/Woodland Drive intersection. <u>More information on this concept.</u>

Annual and Special Town Meeting Warrants – Updated drafts of the 2020 Annual and Special Town Meeting Warrants can be reviewed <u>2020 Annual and Special Town Meeting Warrants</u>.

Transfer Station Rules and Regulations – The proposed FY2021 operating budget includes proposals to eliminate the acceptance of construction and debris (C&D) materials and provide for enhanced security and stricter enforcement. This conversation will continue over the next few Board of Selectmen meetings. <u>Current rules and regulations</u>.

Sylvester and Salmond Properties – The Board of Selectmen will begin more in-depth discussions of these two properties starting at their March 2nd meeting. Discussions will continue over the course of a number of meetings.

Emergency Dispatching – Currently the Town Manager, Fire and Police Chiefs, and Finance Director are working with The Collins Center (UMASS-Boston) on a review of our emergency dispatching service and options for how this service might be delivered in the future.

Buildings Commissioner and Inspectional Services

1775 Washington Street Hanover Crossing – All demo permit information has been received and the permit is set to be released early next week. <u>Additional information</u>.

2053 Washington Street Merchant Row – Currently 12 certificates of occupancy issued. Two new restaurants currently under construction. Alba unit 100 approx. 8000 sq. ft. and Flanders field also approx. 8000 sq. ft. Both expecting to open late spring early summer. Additional information.

548 Washington Street - Yale Appliance – Project is complete with exception of the elevator. The shop is open and running on a temp Certificate of Occupancy.

1095 Washington Street - New Bank is complete and is up and running open for business. Additional information.

175 Winter Street – The Building Dept. has conducted 7 inspections since the fire on 1/24/2020. I have issued Unsafe Structure orders on the fire remains and a free standing firewall that an engineer has deemed unsafe. The order forbids any and all occupancy of surrounding structures within 40 ft. of the firewall.

283 Columbia Road – Prevites is under way. The concrete footings have been poured and the foundation wall sections are soon to follow. <u>Additional information</u>.

1835 Washington Street Chick-fil-A – The project is very close to completion. The inside finishes are complete and they are waiting on issues with Columbia Gas and National Grid. Top coat in the parking area is scheduled for late March and expected opening is early April. <u>Additional information</u>.

Statistics for February 2020 -

- The Building Department has issued 45 permits to date and completed 95 inspections.
- Plumbing and Gas has issued 47 permits to date and completed 60 inspections.
- Electrical has issued 27 permits to date and completed 33 inspections.
- Mechanical has issued 3 permits to date and completed 3 inspections.
- The office has handled 300 phone calls and 147 people at the counter.
- Weights and Measures performed 7 inspections.

Conservation Commission

Off King Street - Fireworks Site Project – Work continues at this site to find and remove munitions and other related materials from wetland areas and associated buffer zones. As the cleanup continues, it was necessary this month for several items to detonated in place for safety reasons. All items found are stored in appropriate containers for removal from the site to licensed disposal facilities. The Notice of Intent based on the most recent MA DEP approved Scope of Work within the waterbodies is still pending.

1775 Washington Street - Hanover Crossing Project – Site inspections continue as the Mall prepares for the demolition of the Wal-Mart building. This phased project has commenced with the placement of safety fence around the current work area, erosion and sedimentation control materials- 18" thick staked mulch tube to protect the adjacent wetlands and Third Herring Brook, and all stormwater basins have been fitted with approved storm drain sediment filter bags. The Conservation Agent's 2/28/20 site inspection found that adequate protection of resource areas is in place and the site is prepared for the demolition project which is scheduled for Monday, March 2nd.

1775 Washington Street - Peterson Pond Dam Removal Project – This project has not commenced as of yet.

637 Washington Street - Starland – An application for approval of wetland boundaries, an Abbreviated Notice of Resource Area Delineation (ANRAD), has been filed for this site. The public hearing is scheduled for Wednesday, March 4 at 6:45 in the second floor hearing room at Town Hall. The Commission will review the plans for accuracy of wetland boundaries, locations, and types only. No construction has been proposed with this application. By determining the boundaries and types of resource areas on site, the associated *no-disturbance* and *no-structure* setbacks can be determined, as well as associated buffer zones.

1969 Washington Street - Cumberland Farms – The Conservation Agent's recent site inspection found that only minor cleanup and brush cutting has taken place at this site thus far. As the Order of Conditions has been issued and recorded at the Plymouth County Registry of Deeds for this project, work may commence at any time.

Rails to Trails Project – The Conservation Agent and Community Development and Municipal Inspections (CDMI) Director announced that the Rails to Trails Project Feasibility Study proposal has been accepted from a local engineering firm and that a meeting is pending the first week in March for contract signatures. A meeting between representatives of the above firm, Conservation, Open Space, and Rails to Trail Project committee members will be planned for mid-March to start the process.

MS4 Application/Permit – As per recommendations rising out of working with the MS4, the Conservation Agent and Building Inspectors are coordinating stormwater inspections for all ongoing projects. As such, combined site inspections have taken place, as well as interdepartmental discussions and meetings. Coordination and cooperation between departments has always been and will continue to be an essential function within CDMI. Commercial Site Review – The Conservation Agent and Health Agent continue their efforts to inspect commercial sites in town for site maintenance and cleanup. Food waste, windblown debris from over packed disposal containers, un-fenced or damaged trash container areas, and similar, often is deposited in protected wetland areas, can harm wildlife, and can cause stormwater basins to become clogged. All issues found at sites thus far have been addressed with appropriate cleanup in a timely manner.

MOU with HYAA – The Field Permit meeting was held on February 13th. The <u>Parks and Recreation Committee</u> will continue to review the current agreement between the Town and HYAA which expires on March 31, 2020.

Build the Boards – We are hoping to complete the large roller hockey rink during the month of June (2020). In order to complete this project, voters will need to approve the updated language for this project at the Annual Town Meeting this May. To keep this project moving DPW will be adjusting the fence and rebuilding the access road within the next four to six weeks. <u>Additional information</u>.

Hanover High School Tennis Courts – Due to cost, the project will be advertised as asphalt courts rather than concrete. Originally scheduled to begin construction right after the spring tennis season. The School Department has requested a minor delay to accommodate their summer program. Plans and specifications are ready and will be bid with a contract start date of approximately August 1st with work expected to take approximately six weeks. Follow this project.

Water Disinfection Byproducts – All construction work is completed including the installation of new chemical feed equipment, safety equipment, and controls at all three treatment plants. Startup testing including calibration, chemical feed adjustment, and control adjustments have been underway for approximately six weeks to ensure reliable operations and proper water chemistry. Reliability issues of the chlorine (bleach) feed systems at Beal and Broadway where water pressures are high have resulted in changes to pumps which have delayed startup, but all of the equipment is now in and we are progressing towards final sign-off and approval by Massachusetts DEP. Follow this project.

Cedar School Security Entrance – The <u>project</u> went out to bid and the bids came back with the low bidder approximately \$100,000 less than the second low bidder. The low bidder has since indicated they had an arithmetic error and would be unable to honor their bid. The second low bid is approximately \$100,000 over the allotted funds.

Broadway and Elm Street Intersection – Proposals for design services have been sent out to three firms. We are awaiting proposals and expect to award a design contract in the next six to eight weeks. Elm Street is scheduled for an overlay this summer. The intersection improvements are not likely to take place until the summer of 2021 at the earliest due to scheduling and finances. Special and Annual Town Meeting (2020) – Preparations for the <u>May Annual and Special Town Meetings</u>, and the <u>Fiscal</u> <u>Year 2021 Budget</u>, are progressing after the presentation of the Town Manager's proposed FY2021 Budget at a joint meeting of the Board of Selectmen and Advisory Committee on February 3. The Advisory Committee's meetings with Departments to review their FY2021 Operating Budgets are proceeding as listed below. As of this writing 47 articles have been drafted for the Annual Town Meeting warrant, and 8 for the Special Town Meeting warrant. **Fiscal Year 2020 Quarter 3 Real Estate Taxes** – These were due February 3, and the Office was as usual very busy providing customer service to residents paying their taxes in person, online, or by mail. An increasing number of taxpayers are choosing to pay their taxes via automatic payment online, a "set it and forget it" system linked to the taxpayer's bank account.

Monthly Budget Reports - Fiscal Year 2020 Monthly Reports.

Town Accountant's Office

Fiscal Year 2019 Audit – The Town Accountant, in conjunction with the Director of Finance/Treasurer Collector, Assessing, and Payroll & Benefits Offices, has been working with the Town's audit firm to complete the Fiscal Year 2019 audit.

Assessing Office

New Growth – The Director of Assessing and Assessing Technician are in the field now inspecting New Growth in the Town to ensure all residential and commercial real estate is taxed at its full and fair value in Fiscal Year 2021.

Real Estate Tax Exemptions – Fiscal Year 2020 real estate tax exemption applications from senior citizens, disabled veterans, and blind residents are due April 1st.

Real Estate Tax Abatements – Real estate tax abatement applications were due February 3rd and are being evaluated now by the Assessing Office and the Board of Assessors.

Payroll and Benefits Office

Activities – The workload of the Payroll and Benefits Office has increased significantly due to the federal Affordable Care Act. One aspect of this is the issuance of 1095-C IRS Forms to all Town and School employees, which was completed in mid-February.

Board of Registrars of Voters

Upcoming Elections Information – The last day to submit signatures to be a candidate on the ballot for open positions at the Annual Town Election is March 20. The last day to register to vote to participate at the May 4 Annual Town Meeting and May 9 Annual Town Election is April 14.

Voting – The Massachusetts Presidential Primary Election is March 3, with early voting occurring February 24-28 during Town Hall hours.

Sequoya Lane Structure Fire - At approximately 5:10 pm on January 22, 2020, the Hanover Fire Department received a call reporting a structure fire at 67 Sequoya Lane. Box 42 was struck and a 1st Alarm Assignment was dispatched. First arriving firefighters found a single family residential building with heavy fire showing from an attached two car garage. A 2nd Alarm Assignment was requested by Chief Blanchard bringing mutual aid assistance from Hanson, Rockland, Norwell and Marshfield Fire Departments to the scene along with resources from the Massachusetts Department of Fire Services. Crews were able to contain the fire to the attached garage with smoke damage occurring throughout the structure. Extensive overhaul was required to ensure the fire was extinguished completely.

A resident was transported to a local hospital after suffering burns and possible smoke inhalation.

The Pembroke Fire Department provided station coverage during the incident. The Hanover Police Department and the Hanover Department of Public Works as well as the Department of Municipal Inspections assisted fire crews on the scene.

Winter Street Structure Fire - On January 24, 2020 at 1:29 pm, the Hanover Fire Department received a call reporting a structure fire at 175 Winter Street. A 1st Alarm Assignment was dispatched. First arriving crews found heavy smoke and fire coming from the left side of a 100' x 120' one story wooden warehouse. The fire had already ignited several outside propane tanks that were stored up against the structure. Initial hose streams were directed onto the propane tanks to keep them from exploding. The fire was progressing rapidly through the structure and firefighters focused on protecting additional propane tanks and nearby structures. Several small explosions occurred inside the building during the fire. Five Alarms were necessary to bring the fire under control.

Mutual Aid assistance from Rockland, Hanson, Norwell, Pembroke, Abington, Whitman, Halifax, East Bridgewater, Kingston, Scituate, Brockton, Hingham, Marshfield and Plympton responded to the scene. Rehab units from the Massachusetts Department of Fire Services, Providence Canteen, American Red Cross and Salvation Army supported incident operations. The Hanover Police and Public Works Departments also assisted on scene. The Hanover Emergency Communications Center coordinated incident communications and requests for mutual aid as well as several other incidents that occurred during the fire.

The Massachusetts Department of Fire Services District Hazardous Materials Response Team was requested to the scene to provide air monitoring at the fire scene and in the neighborhoods that surrounded the area. The Massachusetts Department of Environmental Protection had a representative on scene to assess the impact of water runoff to the area. After the fire was brought under control Pilgrim Propane responded a team to the scene to assist firefighters with a leaking propane tank.

No Firefighters were injured during the incident.

Bradford Road Structure Fire - At approximately 10:45 pm on February 3, 2020, the Hanover Fire Department received several 911 calls reporting a structure fire at 22 Bradford Road. Box 42 was struck and a 1st Alarm Assignment was dispatched. First arriving firefighters found heavy fire showing from the kitchen and an exterior three season porch of a single family residential building. A Working Fire Assignment was requested bringing mutual aid assistance from Hanson to the scene.

Crews made an aggressive attack on the fire and were able to contain it to the kitchen, preventing spread to the remainder of the structure. The house sustained significant smoke damage. Extensive overhaul was required to ensure the fire was extinguished completely.

The Norwell Fire Department provided station coverage during the incident. The Hanover Police Department and the Hanover Department of Public Works as well as the Department of Municipal Inspections assisted fire crews on the scene. Hanover Emergency Communications Center staff fielded multiple calls and communications during the incident.

No injuries were reported.

Statistics for February 2020 – In the month of January, the Hanover Fire Department fielded 292 calls. 70.9% of all calls in the Town of Hanover were reached within six minutes or less.

The study committee is expected to provide objective analysis (pros and cons, and other considerations) on reasonably probable options; the study committee does not have the burden of making a recommendation.
